Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, BRADSHAW INDUSTRIES, INC. a Florida corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is BRADSHAW INDUSTRIES, INC.
2. The original Articles of Incorporation for the corporation were filed on October 27, 2000, and assigned Document No. P00000101330.
3. The Amendment to change the name of the corporation was proposed by the Board of Directors and approved by the Shareholders and Directors on January 17, 2002. The Articles of Incorporation are amended as follows:

Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:


**"ARTICLE I
