## ARTICLES OF INCORPORATION OF DRIVE AWAY, INC.

In compliance with the requirements of Chapter 607, <u>Florida Statutes</u>, the undersigned being natural persons, do hereby act as an incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation under the Florida Business Corporation Act.

#### **ARTICLE VIII**


The existence of the corporation shall begin on October 25, 2000. This corporation is to exist perpetually.
