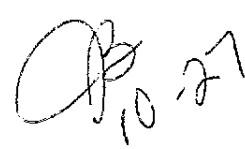

This corporation is authorized to issue 10,000 shares of \$.10 par value common stock, all of one class and series.

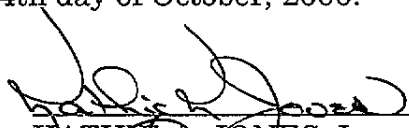

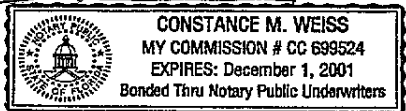

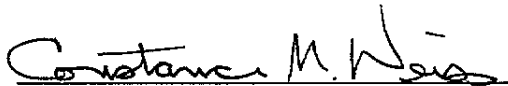
