That pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

First: Be it amended that Article I of the original Article of Incorporation has been changed to Universal Soccer Association, Inc..


Second: Be it amended that the corporations name has been changed to the above.

Third: Be it amended that Article IX of the original Article of Incorporation has been changed to include Gregory F. Taylor a Director of the corporation.
