ARTICLES OF INCORPORATION OF B.L. VAUTRIN & ASSOCIATES, INC.

ARTICLE I. NAME

The name of this corporation is B. L. Vautrin & Associates, Inc.

ARTICLE II. PURPOSE OR PURPOSES

The period of the corporation's duration shall be perpetual.

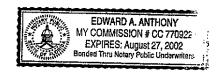
