ARTICLE I. NAME

The name of this corporation is B. L. Vautrin & Associates, Inc.

ARTICLE II. PURPOSE OR PURPOSES

The purpose or purposes for which the corporation is organized are:

- (a) To manufacture, produce, purchase or otherwise acquire, sell, or otherwise dispose of, import, export, distribute, deal in and with, whether as principal or agent, goods, wares, merchandise, and materials of every kind and description, whether now known or hereafter to be discovered or invented, and to engage in any other business activity;
- (b) To enter into any lawful arrangements for sharing profits and losses in any transaction or transactions, and to promote and organize other corporations;
- (c) To have and to exercise all rights and powers that are now or may hereafter be granted to a corporation by law. The foregoing shall be construed as objects, purposes and powers, and the enumeration thereof shall not be held to limit or restrict in any manner the powers now or hereafter conferred on this corporation by the laws of the State of Florida. The objects, and powers specified herein shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clause or paragraph of these articles. The objects, purposes and powers specified in each of the clauses or paragraphs of this Certificate of Incorporation shall be regarded as independent objects, purposes or powers.

ARTICLE III. CORPORATION OFFICE

The office of the corporation within the State of Florida is to be located in the City of Cocoa Beach, Brevard County at 1485 N. Atlantic Ave., #112, Cocoa Beach, Florida.

ARTICLE IV. CAPITALIZATION

The aggregate number of shares which the corporation shall have authority to issue is 200, without par value.

ARTICLE V. ISSUANCE OF SHARES

Shares of stock in the corporation shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1986, as amended.

ARTICLE VI. INITIAL REGISTERED AGENT

The initial registered agent is L. George Leonard, at 1485 N. Atlantic Ave., #112, Cocoa Beach, Florida 32931.

ARTICLE VII. DURATION

The period of the corporation's duration shall be perpetual.

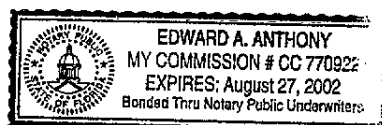
