

ARTICLES OF INCORPORATION OF

VAZQUEZ ESCARPANTER MEDICAL SERVICES, INC.

THE UNDERSIGNED subscribers to these ARTICLES OF INCORPORATION is a natural person competent to contract and hereby form a corporation for profit under chapter 607 of the Florida Statutes.
