The undersigned Incorporator hereby forms a corporation under the laws of the State of
Florida:

ARTICLE I. CORPORATE NAME

The name of this Corporation is:

ARTICLE III. CAPITAL STOCK

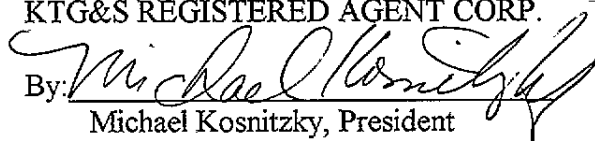
ARTICLE IX. INDEMNIFICATION

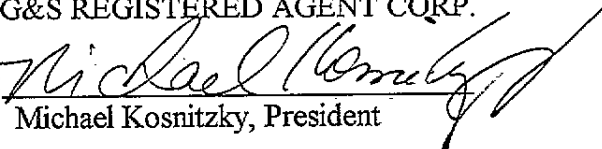
