ARTICLES OF INCORPORATION

OF

We, the undersigned incorporator to these Articles of Information, do hereby adopt the following Articles of Incorporation for the formation of a corporation under the laws of the State of Florida:

ARTICLE I

NAME

The name of this corporation shall be:

LIFE'S NEW BEGINNINGS, INC.

ARTICLE II

ADDRESS OF PRINCIPAL OFFICE

The street address of the principal office of this corporation in the State of Florida shall be 7031 Rockwood Drive, Port Richey, FL 34668-3838. The Board of Directors may from time to time move the principal office to any other address in Florida and may establish branch and other offices within the State of Florida..

ARTICLE III

PURPOSE

The general purposes for which the Corporation is organized are the following:

To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

To do all and everything necessary and proper for the accomplishment of any of the objects or purposes enumerated in the Florida General Corporation Act, in these Articles of Incorporation or any amendment thereto, or in the furtherance thereof or necessary or incidental to the protection and benefit of the objectives for which this corporation is formed, and to have all of the powers conferred upon this corporation by the laws of the State of Florida or of any other stat or country and not prohibited by the Florida General Corporations Act.

The objects and purposes specified in the foregoing clauses of this Article, unless expressly limited, shall not be limited or restricted by reference to, or inference from, any provision in this or any other Article of these Articles of Incorporation, and shall be construed as powers as well as objects and purposes, all as permitted by law.

ARTICLE IV

The authorized capital stock of this corporation shall consist of five hundred (500) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

The number of Directors may be increased or diminished from time to time as determined by the By-laws, but shall never be less than one (1). 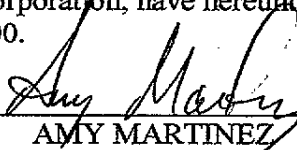
