ARTICLES OF INCORPORATION

The undersigned incorporator, for the purposes of forming a professional corporation under Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME AND ADDRESS

The name of the corporation shall be New Tampa Internal Medicine, P.A. (the "Corporation"). The address of the principal office of the Corporation shall be 114 West Jean Street, Tampa, Florida 33604, and the mailing address shall be the same.

ARTICLE II. PURPOSE

The Corporation is organized for the sole and specific purpose of rendering professional medical services; nevertheless, it shall be authorized to transact any or all lawful business as provided by Chapter 621 of the Florida Statutes, as it exists on the date hereof or as it may hereafter be amended.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is one hundred thousand (100,000) shares of common stock having a par value of \$0.01 per share.

ARTICLE IV. INITIAL REGISTERED AGENT AND STREET ADDRESS

The street address of the initial registered office of the Corporation shall be 401 E. Jackson Street, Suite 2500, Tampa, Florida 33602, and the name of the initial registered agent of the Corporation at that address is Patricia L. Radzinski.

ARTICLE V. INCORPORATOR

ARTICLE VI. NUMBER OF DIRECTORS

The business of the Corporation shall be managed by a Board of Directors consisting of not fewer than one (1), the exact number to be determined from time to time in accordance with the Bylaws.

ARTICLE VII. INITIAL BOARD OF DIRECTORS




