ARTICLE I: NAME

THE NAME OF THE CORPORATION IS INTERNET COAST CHAMBER OF COMMERCE, INC. THE MAILING ADDRESS OF THE CORPORATION IS 3045 NORTH FEDERAL HWY SUITE 60, FORT LAUDERDALE, FL 33306.

ARTICLE II: DURATION

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

ARTICLE III: PURPOSE

ARTICLE IV: CAPITAL STOCK

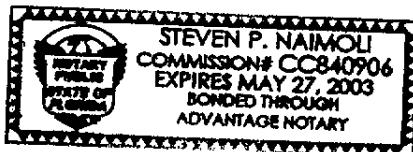
