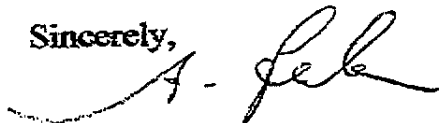

ARTICLE OF INCORPORATION OF CENTAUR IMPEX, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following articles of incorporation.

ARTICLE I Name of Corporation

The name of this corporation shall be Natasha International, Inc.

ARTICLE II Registered Office

The initial principle place and street address of business will be 1628 Fennsbury Court, Wesley Chapel, Florida 33543 and the mailing address of corporation will be P O Box 46686, Tampa, Florida 33647-0106.

ARTICLE III Purpose and Powers

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act, as in effect from time to time. The corporation shall have all the powers set forth in the Florida General Corporation Law, as in effect from time to time.

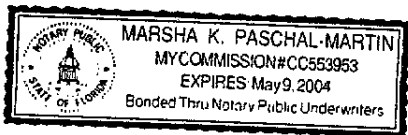
