**ARTICLES OF INCORPORATION  
OF  
AUGI I, INC.**

**FIRST. Name.** The name of this corporation is: **AUGI I, INC.**

**SECOND. Nature of Business.** This corporation has been formed to transact any and all lawful business and to exercise all powers granted to corporations by the laws of the State of Florida. In furtherance of the foregoing, and not in limitation thereof, this corporation shall have the power and authority to do everything necessary, proper or incidental to the accomplishment of its purposes.

**THIRD. Principal Office.** The principal office and mailing address of this corporation will be located at 2975 Bee Ridge Road, Suite D, Sarasota, Florida 34239, or at such other address as may be determined by the board of directors.

**FOURTH. Shares.** The total number of shares that this corporation is authorized to have outstanding at any one time is one hundred million (100,000,000) shares without par value which shall be designated common stock, of which fifty million (50,000,000) shares are Class A Common Stock and fifty million (50,000,000) shares are Class B Common Stock. The relative rights, preferences and limitations of the shares of the Class A Common Stock and the shares of the Class B Common Stock are identical in all respects, except that the voting power for the election of directors and for all other purposes is vested exclusively in the holders of the shares of the Class A Common Stock, and, except as otherwise required by law, the holders of shares of the Class B Common Stock are not to have any voting power or be entitled to receive notice of meetings of shareholders. In all matters in which they have the right to vote, the holders of shares of the Class A Common Stock have one (1) vote per share and the holders of shares of Class B Common Stock have one (1) vote per share.

**FIFTH. Initial Registered Office.** The street address of the initial registered office of this corporation is 1301 Riverplace Boulevard, Suite 1500, Jacksonville, Florida 32207, and the name of the initial registered agent of this corporation at that address is Charles R. Curley, Jr.

**SIXTH. Initial Board of Directors.** The names and addresses of the members of the first board of directors, who shall hold office for the first year of the existence of the Corporation or until their successors are elected or appointed and have qualified are:

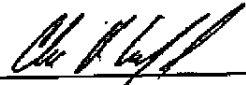
