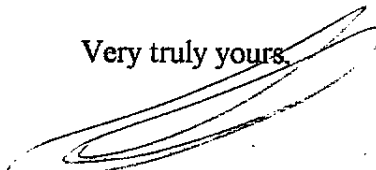

ARTICLES OF INCORPORATION OF

ARTICLE I.

CORPORATE NAME

The name of this corporation shall be: Slow Money Entertainment, Inc.

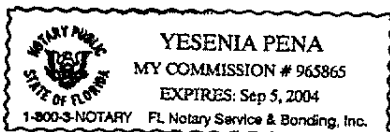

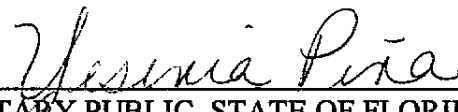
