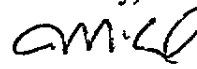

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is **ROCKY HAMMOCK ENTERPRISES, INC.**

**ARTICLE II**

The existence of the corporation shall begin on November 1, 2000.
