The undersigned, for the purpose of forming a corporation under the Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of this corporation is **DIAGNOSTIC CLINICAL IMAGING, INC.**

**ARTICLE II
PURPOSE**

This corporation is organized for the purpose of providing diagnostic imaging for medical practices to assist in with the patient needs, medical conditions, diagnosis and treatments, as well as all other related activities permitted under the laws of the State of Florida and the United States of America.

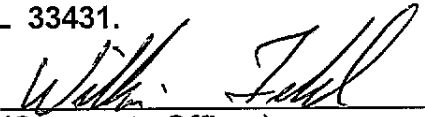

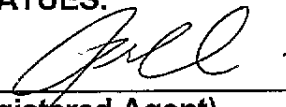
