The undersigned hereby forms a Florida professional service corporation under Chapter 621 of the laws of the State of Florida.

**ARTICLE I. NAME AND ADDRESS**

The name of the corporation shall be:

**ARTICLE II. NATURE OF BUSINESS**

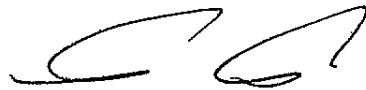
