ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, hereby make, subscribe, acknowledge and file these Articles of Incorporation and acts as incorporator for the purpose of forming a corporation for profit under the laws of the State of Florida, and does hereby adopt the following Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation shall be

NATURE OF BUSINESS

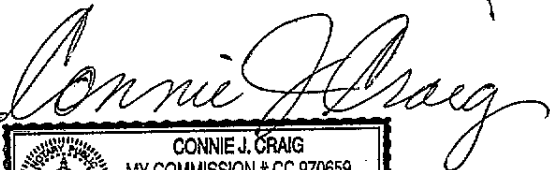

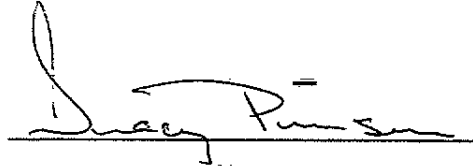
ARTICLE VIII

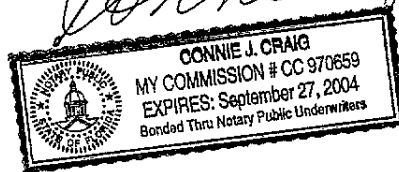
