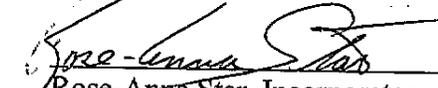

AMENDMENT**

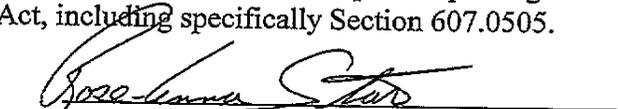
