

ARTICLE I - NAME

The name of this Corporation shall be:
Shiflett Enterprises, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on 11/01/00

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any
and all lawful business.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue Two Hundred (200)
shares of \$1.00 Par Value Stock.

shares) at the price at which it is offered to others.
