**ARTICLE I - NAME**

The name of this corporation is JDR MANAGEMENT, INC.

**ARTICLE II - PRINCIPAL PLACE OF BUSINESS**

The principal place of business of the corporation is 202 Plantation Road, Palm Beach, Florida 33480.

**ARTICLE III - DURATION**

This corporation shall exist perpetually commencing as of the date these Articles are filed with the Secretary of State's office.

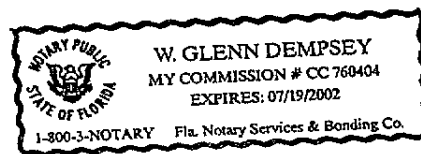
