**ARTICLE I - NAME**

The name of this Corporation is NATALIE'S HOME FASHIONS, INC.

**ARTICLE II - DURATION**

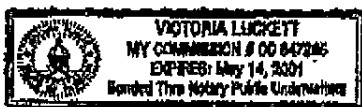


