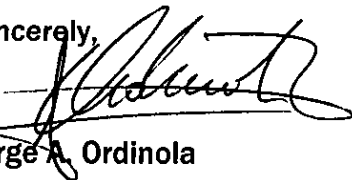
Please be advised that we have now been retained as accountants for the client in question. We have been asked to write in their behalf.
