ARTICLE I

Name. The name of this corporation is COAST TO COAST COURIERS, INC.

ARTICLE II

Business and Activities. This Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

Capital Stock. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors.

ARTICLE IV

Initial Registered Office and Agent. The street address of the initial registered office of the corporation is 4044 Lake Mary Blvd., Unit 104 - #323, Lake Mary, Florida 32746, and the name of the initial registered agent of this corporation at the address is Valerie P. Long. The principal office shall be the same.

ARTICLE V

Number of Directors. The Board of Directors of this corporation shall consist of one or more Directors, the exact number of which shall be the number of directors from time to time fixed by the Board of Directors or the stockholders in accordance with the By-Laws of the Corporation. Directors, as such, shall receive such compensation for their services, if any, as may be set by the Board of Directors at an annual or special meeting. The Directors may authorize and require the payment of the reasonable expenses incurred by Directors in attending meetings of the Directors. Nothing in this Article shall be construed to preclude a Director from serving the Corporation in any other capacity and receiving compensation therefore.

ARTICLE VI

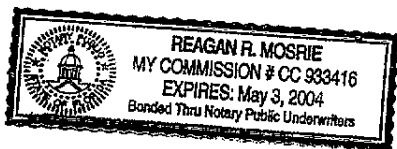
