THIRD: Adoption of Dissolution

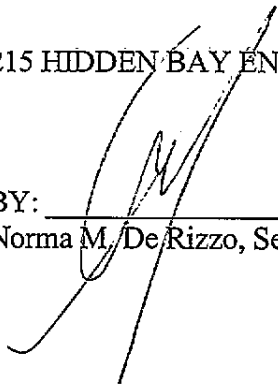
Dissolution was approved by the Unanimous Decision of Shareholders and Board of Directors. The number of votes cast for dissolution was sufficient for approval.
