

ARTICLES OF INCORPORATION OF TINKIE BELL, INC.



Article I - Name

The name of this corporation is TINKIE BELL, INC. and its principal office is located at 1874 Wickham Road, Melbourne, Florida 32935.

Article II - Duration

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these articles are filed with the Secretary of State.
