Articles of Incorporation executed by the undersigned for the purpose of forming a corporation under the Florida Business Corporation Act for the purpose of operating a medical practice.

ARTICLE I

The name of this Corporation shall be Fazlur Rahman, M.D., P.A., and the initial address of this Corporation shall be 7916 Harmony Lake Court, Fort Myers, Florida 33907.

ARTICLE II

The Corporation shall have all of the common law and statutory powers and duties of a corporation for profit under the laws of the State of Florida, except as limited or modified by these Articles or Bylaws.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of the Corporation.

This Corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE V

The initial registered office of this Corporation shall be at 7916 Harmony Lake Court, Fort Myers, Florida 33907 with the privilege of having its offices and branch offices at other places within or without the State of Florida. The initial registered agent at that address shall be Fazlur Rahman, M.D.

ARTICLE VI

This Corporation shall have at least one (1) Director, with the exact number to be fixed by the Bylaws.

ARTICLE VII

ARTICLE X
