

Gentlemen:

I received your letter of June 6, 2001, in which you claim that 2001 Uniform Business Report of KVC Incorporated was not properly completed. Although I have signed the form as per your request, I believe that you are mistaken in claiming that I needed to sign the form as the new registered agent.

The UBR was not used to change the registered agent or office of the company. Rather, on April 11, 2001, "A Statement of Change of Registered Office or Registered Agent or Both for Corporations" was filed with the Florida Department of State. A check for the \$35 fee was cashed by the Florida Department of State on April 16, 2001 (see enclosed). Since the registered agent and office were presumably changed effective that date, the UBR did not serve that purpose. If, however, the "A Statement of Change of Registered Office or Registered Agent or Both for Corporations" was not accepted in April, please refund to us the \$35 paid at that time.
