Article 1

Corporate Name

The Name of this corporation is: H2H, Inc.

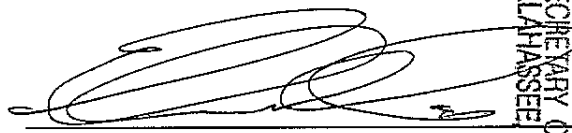
