**ARTICLES OF INCORPORATION
FOR

ARTICLE I

ARTICLE IV

Capital Stock

ARTICLE XII

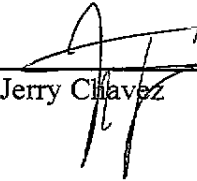
Officer

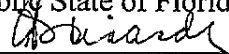

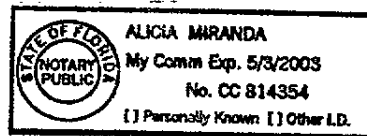

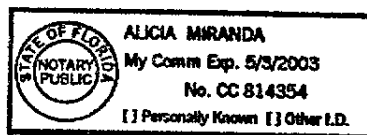
