ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation not for profit under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of this corporation is:

CHIROPRACTIC NOT CHIROPRACTIC MEDICINE, INC.

ARTICLE II

DURATION

This corporation shall have perpetual existence unless dissolved pursuant to law and shall commence business as of the date of filing of these Articles of Incorporation.

ARTICLE III

PURPOSE

This corporation may engage in any activity of business permitted under the laws of the State of Florida, said corporation's primary purpose to be a patient advocate group to maintain chiropractic as a separate philosophy, art and science.

#### ARTICLE IV

##### CAPITAL STOCK

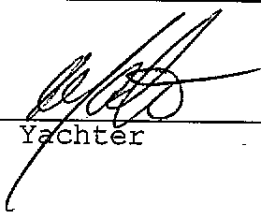
