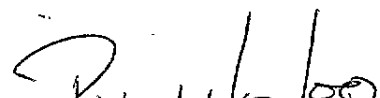

## ARTICLES OF INCORPORATION

SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

### ARTICLE I

The name of this corporation shall be:

**Sports Car Center of Orlando, Inc.**

### ARTICLE II

The principle office of this corporation shall be 311 Altamonte Commerce Blvd., Suite 1612, Altamonte Springs, Florida 32714, but this corporation may establish such other offices and branch offices within or without the State of Florida as may be necessary or as may be determined by the board of directors.

### ARTICLE III

The amount of capital stock authorized by this corporation shall be 150,000 shares with a par value of \$0.01 per share.

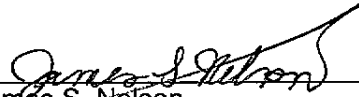

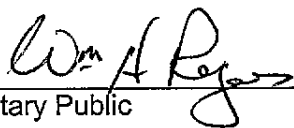

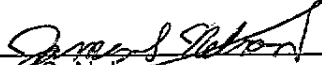
