ARTICLES OF INCORPORATION ARTOMIS, INC.



The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribes to the formation of a Corporation under the laws of the state of Florida.

ARTICLE I

The name of the Corporation is ARToMIS, Inc.

ARTICLE II

This Corporation shall commence upon the filing of these Articles and shall exist perpetually.

ARTICLE III

The purpose of this Corporation is to engage in educational services, provide business support and technical services, and to engage in any business lawful under the laws of the State of Florida or the United States of America.

ARTICLE IV

This Corporation is authorized to issue Ten Thousand (10,000) shares of common stock, valued at \$1 Par. The shares of this Corporation are not to be divided into classes, except by majority vote of the Board of Directors. This Corporation is not authorized to issue shares in series.

ARTICLE V

Every Shareholder, upon the sale for cash of any new stock of this Corporation, shall have the right to purchase his prorata share thereof (as nearly as can be done without issuing fractional shares), at the price at which the Stock is offered to others.

The initial Board of Directors of the Corporation shall consist of one (1) Director. The number of Directors may either be increased or decreased from time to time by the By-Laws, but may never be less than one (1) Director.
