

ARTICLES OF INCORPORATION
OF
DJ WELCER PROPERTIES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of this corporation is DJ WELCER PROPERTIES, INC.

ARTICLE TWO

The corporation is to have perpetual existence.

ARTICLE THREE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act. The specific purpose of the corporation is to purchase and sell real property, manage real property owned by the Corporation and maintain real property owned by the Corporation .

ARTICLE FOUR

4.01 The aggregate number of shares which the corporation shall have the authority to issue is 500, all of which shall be common shares with a par value of \$1.00 per share.

4.02 The minimum amount of paid-in capital with which the corporation shall begin business shall be not less than Five Hundred Dollars (\$500.00).

ARTICLE FIVE

5.01 The street address of the initial corporate office of the corporation is 6230 Leslie Street, Jupiter, Florida 33418.


ARTICLE EIGHT

The effective date of this corporation shall be the filing date of these Articles of Incorporation.






