ARTICLE I - NAME

The name of this Corporation is Coptic, Inc. and the address is 6801 Forest City Road, Orlando, Florida 32810.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS
