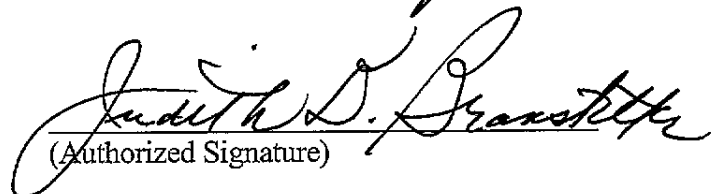

The Name of the corporation shall be **MILART, INC.**

II

The duration of the corporation shall be perpetual.

III
