The undersigned subscriber to these Articles of Incorporation, being a natural person and competent, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I. NAME

PV Desk Systems, Inc. is the name of this corporation.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS

The corporation's principal place of business is at 4500 140th Avenue North Suite 101 Clearwater, Florida 33762.

ARTICLE III. PURPOSE

This Corporation is organized for the purpose of engaging in all lawful businesses permitted to a corporation under the Florida General Corporation Law, as in effect from time to time.

ARTICLE IV. CAPITAL STOCK AUTHORIZED

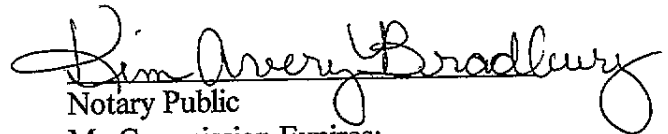

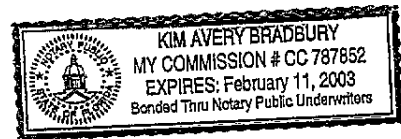

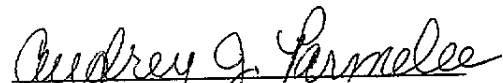
