The corporation shall indemnify each officer and director to the fullest extent permitted by Chapter 607, Fla. Stat.

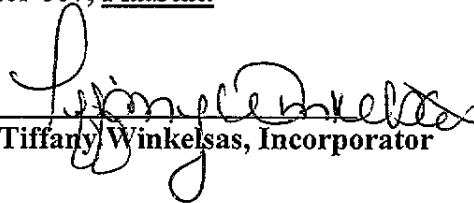

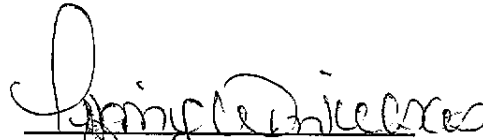
