ARTICLES OF INCORPORATION FOR SECURITY NATIONAL ADJUSTMENT GROUP, INC.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE NAME

The corporate name shall be: Security National Adjustment Group, Inc.
