**ARTICLE I. CORPORATE NAME**

The name of this Corporation is RJM Software Solutions, Inc.

**ARTICLE II. CORPORATE PRINCIPAL OFFICE AND MAILING ADDRESS**

The Corporation principal office and mailing address is 3441 Hinsdale Court, Clearwater, FL 33761.

**ARTICLE III. NATURE OF BUSINESS**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE IV. CAPITAL STOCK**

The maximum number of share of stock that this Corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock without par value.


### **ARTICLE XI. PRE-EMPTIVE RIGHTS**
