**ARTICLE I - NAME**

The name of the corporation is: **ISTC, INC.**

**ARTICLE II - DURATION**

This corporation shall exist perpetually.

**ARTICLE III - PURPOSE**

This corporation is created and shall exist for the purpose of assisting its shareholders and incorporation in engaging in information systems, telecommunications services within the State of Florida. In furtherance of this purpose, this corporation may engage in, or transact, any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida, or any other State, country, territory or nation.

**ARTICLE IV - CAPITAL STOCK**

This Corporation is authorized to issue 100 shares of stock at \$1.00 par value common stock which shall be designated "Common Shares."

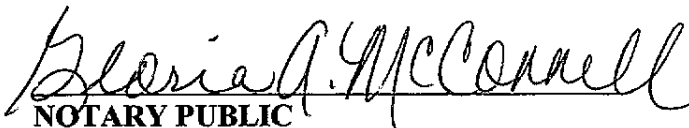

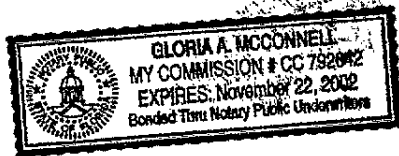
