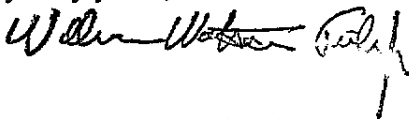

**ARTICLE 1: CORPORATE NAME:** The name of this corporation is Incahoots Pub, Inc.

**ARTICLE 2: PRINCIPAL OFFICE:** The street address of the initial principal office of this corporation is 5620-G Coach House Circle, Boca Raton, Florida 33486.

**ARTICLE 3: MAILING ADDRESS:** The initial mailing address of this corporation is 5620-G Coach House Circle, Boca Raton, Florida 33486.

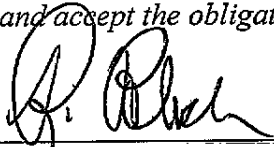
