

I, the undersigned natural person of the age of eighteen (18) years or more, do make and acknowledge these Articles of Incorporation for the purposes of forming a business corporation under and by virtue of the laws of the State of Florida, and herein set forth the following:

1. The name of the Corporation is ENVIRONMENTAL SOURCE SAMPLERS, INC.
2. The period of duration of the Corporation is unlimited.
3. The purposes for which the Corporation is organized are to engage in any lawful act or activity for which corporations may be organized under the General Statutes of the State of Florida.
4. The Corporation shall have authority to issue 100,000 shares of common stock having no par value.


