ARTICLES OF INCORPORATION OF FLORIDA AQUATIC ADVENTURES, INC.

ARTICLE I

The name of the corporation shall be FLORIDA AQUATIC ADVENTURES, Inc.

ARTICLE II

The corporation shall have the power to engage in any lawful activity for which corporations may by organized under Florida law.

ARTICLE III

The aggregate number of shares that the corporation shall have authority to issue and to have outstanding at any one time is 100 shares. All such shares shall be of a single class, designated as common.

ARTICLE IV

Each holder of common shares shall have one vote for each such share held of record on all matters submitted for shareholder approval. No shareholder shall have the preferential or preemptive right to subscribe for or to purchase any shares of any class, any rights, warrants, or options with respect thereto, or any obligation convertible into or exchangeable for any such shares or other securities whether out of unissued shares or other securities or out of shares or other securities acquired by the corporation after the issue thereof, regardless of the consideration therefor.

ARTICLE VI

The period of existence of the corporation is perpetual.

ARTICLE VII

The Florida Control-Share Acquisition sections of the Florida Business Corporation Act (§§ 607.0901 through 607.0903) shall not be applicable to this corporation.

ARTICLE VIII

The bylaws of the corporation may be amended by majority vote of either the directors or the shareholders.

ARTICLE IX

The business of the corporation shall be managed by the shareholders without a board of directors.
