**ARTICLES OF INCORPORATION
OF

ARTICLE 1. NAME. The name of the corporation shall be JON WALTER CORPORATION.

ARTICLE 11. DURATION. The corporation shall exist perpetually.

ARTICLE 111. PURPOSE. The purpose of this corporation is to consult to and manage other businesses and for the purpose of the transaction of any other lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE 1V. CAPITAL STOCK. This corporation is authorized to issue One Hundred Thousand Shares of common stock (100,000), with \$1.00 par value per share, and the consideration to be paid for each share shall be fixed by the Board of Directors.

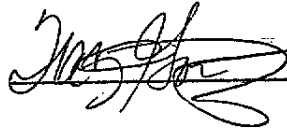
