ARTICLE I - Name

The name of this corporation is **20/20 REAL ESTATE INSPECTION SERVICES, INC.**

ARTICLE II - Principal Office

The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

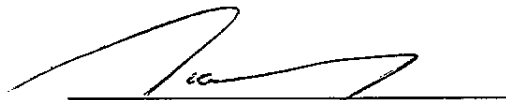
ARTICLE X - Amendment

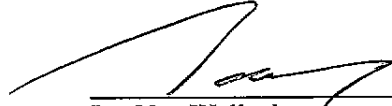
