Article I Name

The name of the corporation is Marquis Productions, Inc.

Article II Duration

The corporation shall have perpetual existence.

Article III
Purpose

The corporation is organized for the purpose of transacting any and all lawful business.

Article IV
Address

The principal place of business of the corporation shall be:

Article V
Capital Stock

The corporation is authorized to issue 750 shares of common stock, \$1.00 par value per share.

Article VI Initial Registered Office and Agent

The indemnification provided herein shall continue as to a person who has ceased to be an officer, director, employee or agent of the corporation, and shall inure to the benefit of the heirs, the personal and other legal

representatives of such person. An adjudication of liability shall not affect the right to indemnification for those indemnified.

Article XI Bylaws

The bylaws may be adopted, altered or repealed by either the shareholders or the board of directors, but the board of directors may not amend or repeal any bylaw provision adopted by the shareholders if the shareholders specifically provide such bylaw is not subject to amendment or repeal by the directors.
