## ARTICLES OF INCORPORATION OF PRIVATE ROADS ENTERTAINMENT, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

#### Article I Name

Section 1.1. Name. The name of this corporation shall be Private Roads Entertainment, Inc.

## Article II Principal Office and Mailing Address

Section 2.1. Principal Office and Mailing Address. The principal place of business and mailing address of this corporation shall be 1210 Salt Creek Island Drive, Ponte Vedra Beach, Florida 32082.
