Michael Reddick undersigned, being of the age of eighteen (18) years or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida

1. The name of the Corporation is. Reddco Entertainment Inc.
2. The number of shares the corporation is authorized to issue shall be 1000 shares all of one class designated as common stock.

No amendment shall be made to this Article when the number of shares voting against the proposal to amend would be sufficient to elect a director by cumulative voting and such shares are entitled to be voted cumulatively for the election of directors.
