of the State of Florida.

ARTICLE I. NAME

ARTICLE V. TERM OF EXISTENCE

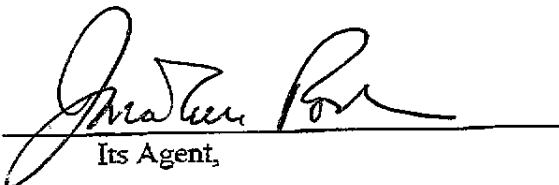
